Why Psychic & Energy Work collects your personal information

Psychic & Energy Work collects your personal information when you visit the website, make an inquiry or order a P&EW product or service. Your data isn't shared with anyone unless that's required for legal, regulatory, tax or product development purposes. We may also share your personal data if disclosure is necessary to protect our privacy, commercial or legal rights; those of other visitors; or the public at large.

Storing your personal information lets us service your inquiries as efficiently as possible and provide you ongoing access to your purchase history and any products or services you've bought. Your data will not be shared with any third party unless it is required as outlined above. You can refuse to provide your personal information but doing so might affect what you can buy and access, and how we can help you. What we collect from you

Psychic & Energy Work keeps a copy of all correspondence relating to its website, products, services, purchases and general matters. This includes the writer's and recipients' names, all email address(es) and the messages sent. At all times, this data will be treated in accordance with this policy.

P&EW collects the following data about any individual or organisation ordering its products or services:

- the name of the individual and/or organisation;
- the purchaser's address and geographic location;
- the email address(es) and contact numbers of any individual and/or organisation purchasing or enquiring about a purchase;
- the purchaser's tax file/registration number where it is required by law in Australia and/or the country of purchase;
- the details of all purchases including the product or service names, prices paid, quantity bought, applicable tax rates, tax paid and date of each order (in addition to the other data listed here);
- all invoices, transaction and account correspondence, including refund and adjustment notices;
- the user names and passwords created for all online customer accounts;
- all logins into online customer accounts.

The above information enables us to service and support your needs as efficiently as possible.

The above data is also held on orders that are only partially completed (i.e. not fulfilled). This information enables us to monitor site use and respond to inquiries over time.

Psychic & Energy Work will collect and/or authorise the collection of more extensive information at any time an unauthorised attempt to interfere with and/or compromise the security of this website and/or its data files is made. This will be done in accordance with Australian and international legislation.

P&EW only transacts with individuals aged below 16 years if their legal guardian has consented.

How Psychic & Energy Work uses cookies

A cookie is a small file which asks permission to be placed upon your device's hard drive. Once you agree, the cookie is added to identify the pages you visit and how you interact with them. Through this, we are able to analyse data about visitor traffic and customer needs; safeguard this website; and customise our responses and offers. Once it is analysed, this data is removed from our system. All statistics gathered in this fashion are the property of Psychic & Energy Work.

In gathering and remembering data about your usage and preferences, cookies help us tailor our responses to you.
